By giving this permission, I understand that I retain any copyright and related intellectual property rights that I may hold. I hereby release the City of Sacramento and CSH, and its assignees and designees, from any and all claims and demands arising out of or in connection with the use of the materials I have contributed, including but not limited to any claims for copyright infringement, defamation, invasion of privacy, or right of publicity. Should any part of the materials I have contributed be found to include materials that the CSH deems inappropriate for retention with the collection, the CSH would not retain the material.
