The City of Sacramento, Community Development Department, Environmental Planning Services has completed preparation of a Draft Mitigated Negative Declaration for the Christian Brothers High School Sports Complex Renovation project and intends to present the document for adoption as part of project review. The document, and related project plans associated with the project entitlements, are now available for a 20-day public review and comment period. The comment period is from **April 16, 2019** to **May 6, 2019**.

The proposed project site is located at 4315 Martin Luther King Jr. Boulevard in the City of Sacramento, California. The 24.25-acre project site is identified by APNs 020-0220-005 and -006. Properties in the general vicinity of the project site consist of residential, some commercial, a church and an elementary school.

The proposed project would include the renovation of an existing sports stadium complex and sports field that would consist of the following components: new stadium lighting; new scoreboard; construction of bleachers with a 1,300-seat capacity; all-weather track and synthetic turf field; perimeter fencing; a new, covered stadium entryway; conduit pathway for future lighting; landscaping; irrigation; construction of a new parking lot; and construction of a new emergency access point. The proposed project would designate a portion of Martin Luther King Jr. Blvd. west of the project site for use as a student pick-up and drop-off location t between the hours of 7 AM and 3 PM, at which time, parking would be prohibited.

Written comments regarding the Draft Mitigated Negative Declaration should be received by the Community Development Department, **NO LATER THAN 4:00 PM on Monday, May 6, 2019** when the public counter closes. Written comments should be submitted to:
