### **DOCUMENTS**

- All written materials received at the hearing will become part of the hearing record.
- Any documents to be presented to the hearing examiner shall be emailed to the secretary and are marked as evidence.
- The agenda is current at the time of posting.

### **TESTIMONY AND EVIDENCE**

- All persons wishing to testify must first take an oath swearing under penalty of perjury that the testimony they are about to give is the truth.
- All persons wishing to speak, must state their name clearly for the record.

### **GENERAL CONDUCT FOR THE VIRTUAL HEARINGS**

- Hearings governed by Sacramento City Code 1.28.010 are not subject to the requirements and provisions under the Ralph M. Brown Act.
- Public comment is not permitted, and members of the public will not have video or audio capabilities during the hearing.
- All hearing participants are cautioned to not speak over each other and to limit background noise (to the extent possible) in order to maintain a clear hearing record and orderly proceedings. At any time, the hearing secretary may mute a participant's microphone and require requests to speak and objections to be noticed by the "raise your hand" function on the online platform to ensure a clear hearing record.
- The hearings are electronically recorded via an online platform, and copies of the recording can be made available by submitting a Public Records Act request through the Office of the City Clerk.
