All persons wishing to testify must first take an oath swearing under penalty of perjury that the testimony they are about to give is the truth.

All persons wishing to speak, please state your name clearly. Please provide a valid email address before the hearing to the secretary and consent to the remote hearing process

Any documents to be presented to the hearing examiner shall be emailed to the secretary and are marked as evidence.

#### **GENERAL CONDUCT FOR THE VIRTUAL HEARINGS**

- All hearing participants are cautioned to not speak over each other and to limit background noise (to the extent possible) in order to maintain a clear hearing record and orderly proceedings. At any time, the hearing secretary may mute a participant's microphone and require requests to speak and objections to be noticed by the "raise your hand" function on the online platform to insure a clear hearing record.
- Members of the public attending the virtual hearings shall observe the same rules and decorum as noted in Chapter 5 of Council Rules of Procedure.
