

Four years ago I ran for City Council because I wanted to bring more efficient and effective resources to our neighborhoods and improve the quality of life for our residents.

I knew District 2, where I grew up, had many challenges. We needed safer streets, better healthcare, cleaner neighborhoods and parks safe for families; and basic amenities like a local full-service grocery store.

Many thought nothing could be done. But I knew the spirit of the people that make up our diverse district was strong and we could move to reach our potential as a healthy, thriving community.

In my first term, we've worked together and made real progress. We invested in the high tech "ShotSpotter Program," and worked with law enforcement to fight crime and violence. We attracted \$1.2 million into one of our tougher neighborhoods and we welcomed our first full-service grocery store in over 20 years and another one is on the way.
