

## **FOOD VENDING VEHICLE PERMIT: CUSTOMER INSTRUCTIONS**

1. All Food Vending Vehicle Permits expire on April 30.
2. **Renewal applications** are accepted March 1-31 to ensure inclusion in the food vending vehicle clinic.
3. **New applications** are taken throughout the year, however, all permits expire on April 30 of the following year.
4. The fee for a Food Vending Vehicle Permit is \$200 (new and renewal).
5. The company must have a valid Business Operations Tax Certificate with the City, which can be obtained here:  
<http://www.cityofsacramento.org/Finance/Revenue/Business-Operation-Tax/Apply-for-a-Business-Operation-Tax-Account>.
6. Applicants must complete the Vehicle Permits Application and provide:
  - a. Personal Disclosure Forms
    - i. Required for each company owner (company owners are those with a 10% or greater interest in the business).
    - ii. Required for all corporate officers of the company
    - iii. Can be completed and submitted online here:

  - b. Proof of insurance coverage including, a certificate of AUTO liability insurance (*truck/trailer only*), GENERAL liability insurance, and the Additional Insured Endorsement. See Insurance Requirement document for more detail.
    - i. Itemize the vehicles covered
    - ii. Shows the City of Sacramento as additional insured
    - iii. Indicates coverage of \$1,000,000 combined single limit per occurrence for both AUTO (*truck/trailer only*) and GENERAL liability.
  - c. Health Permit from Sacramento County Environmental Management Dept.
  - d. A copy of the current DMV registration for each vehicle (*truck/trailer only*).
  - e. Complete the application for a Broadcasting License (\$75 fee) *\*vendors with amplified sound\**

**FOOD VENDING VEHICLE DRIVER PERMIT: CUSTOMER INSTRUCTIONS**

1. All Food Vending Vehicle Driver Permits expire on April 30
2. **Renewal applications** are accepted March 1-31 to ensure inclusion in the food vending vehicle clinic.
3. **New applications** are taken throughout the year, however, all permits expire on April 30 of the following year.
4. The fee for a Food Vending Vehicle Driver Permit is \$162 (new and renewal).
  - a. If you are a new applicant, there is a \$88 fingerprinting fee.
5. Applicants must complete the Special Business Permit Application and provide:
  - a. Current DMV record for the applicant, dated within 30 days.
  - b. A copy of a valid driver's license (new applicants only).
  - c. Two color passport-sized (2"x2") photographs (no hats or sunglasses)
6. Those operating a permitted Food Vending Vehicle **bicycle** are not required to obtain a Driver's Permit, but are required to be fingerprinted and approved prior to operating
