**GENERAL RELEASE—SKATE BOARD PARK**

*This is a release of liability. Read carefully before signing.*

BECAUSE SKATEBOARDING IS AN INHERENTLY DANGEROUS ACTIVITY, THE CITY OF SACRAMENTO IS REQUIRING YOU TO ASSUME ALL RISKS OF INJURY AND RELEASE THE CITY FROM ANY LIABILITY AS A CONDITION OF BEING PERMITTED TO USE THE SKATE PARK.

In consideration of being permitted to engage in skateboarding activities at the City of Sacramento's 28<sup>th</sup> & B Street Skate Park, I hereby voluntarily release, discharge, waive, relinquish, and hold harmless (collectively "Release") any and all claims or actions that I may have now or in the future against the City of Sacramento for damages for personal injury, death, or property damage (the "Risks") that I may suffer resulting from my presence at the Skate Park and/or participation in skateboarding including but not limited to Risks caused by the actions or inactions of me, any other person present at the Skate Park or participating in skateboarding, and any person providing advice or instruction concerning skateboarding. This General Release is intended to discharge, in advance, the City of Sacramento and its officers, employees, agents, and volunteers (collectively "Releasees") from any and all liability arising out of, or connected in any way with my presence and participation at the City's 28<sup>th</sup> and B Street Skate Park and any other City of Sacramento skateboarding facility, even though that liability may arise out of negligence, carelessness, or the improper actions or failure to act on the part of the Releasees, but excluding intentional misconduct.

I understand that skateboarding is an inherently dangerous recreational activity and serious accidents, including grave personal injury or death and property damage, occur from time to time during skateboarding activities. Knowing the Risks, and in consideration of being permitted to enter and participate at the 28<sup>th</sup> and B Street Skate Park and any other City skateboarding facility, I hereby agree to assume those Risks and agree to Release and promise not to sue the Releasees, even though by their act or failure to act, I may suffer injury and damages and the Releasees may otherwise be liable to me and my spouse, partner, children, family, and heirs for my injuries and damages but for this General Release. I further understand and agree that this Release and assumption of Risks is binding on my heirs, executors, administrators, and assigns.

I have read this General Release, I understand that I am giving up substantial rights by signing it. I have had the opportunity to obtain legal advice prior to signing it, and I sign it voluntarily. This General Release shall remain in effect indefinitely until it is revoked in writing by submitting it to the City of Sacramento, Director of Parks and Recreation, 915 I Street, Sacramento, CA 95814, and I thereafter cease from entering or using any City skateboarding facility.

\_\_\_\_\_ (initial if applicable) NO HELMET AND/OR NO PAD PROTECTION WAIVER

I acknowledge that state law provides that: "No operator of a skateboard park shall permit any person to ride a skateboard therein, unless that person is wearing a helmet, elbow pads, and knee pads." I understand that this law is intended to protect me from injury. Nonetheless, I have asked the City of Sacramento to permit me to skate without a helmet and/or without elbow or knee pads, because I am an adult and an experienced skateboarder. I hereby agree to indemnify and hold harmless the City of Sacramento and its officers, employees, agents, and volunteers from liability from any claims based on its failure to force me to comply with this state law.
