As part of the annual Citywide Fee and Charge Adjustments, the City is proposing to increase Transportation Permit fees. The existing City Transportation Permit fees of \$70 per annual permit and \$15 per single trip permit have not changed in over 25 years, and current permit fee revenues are not sufficient to cover costs associated with administering the Transportation Permit Program. Section 35795 of the State Vehicle Code limits local agency Transportation Permit fees to the fee amounts set by the State of California for their permit program. The proposed fee change would increase the City's Transportation Permit fees to the current State rate of \$90 per annual and \$16 per single trip permit to begin to align revenues with program costs. revenues with program costs.
