On December 1, 2015 development of the Railyards is scheduled to begin which includes the extension of F and G Streets through the existing lot into the railyard property. Because of this, Lot 297 will no longer be available for monthly parking after November 30, 2015. Current Lot 297 and 297 North monthly parking customers will be given priority to relocate to Old Sacramento Garage and start their parking effective December 1, 2015 at the rate of \$115 per month. Other City-owned garage facilities, with availability, will also be accepting transfer requests. The effective date of any new parking arrangement will be based on when the transfer is requested.
