## How to get your ultra-low flush toilet (ULFT) or high efficiency toilet (HET) rebate.

1. You must first call the City of Sacramento at 311 or 264-5011 to see if rebates are available.
2. To obtain a rebate, customers must agree to a Water- Wise House Call. This service is at no direct cost to the customer.
3. Purchase and install the new toilet(s). You must be replacing a toilet using 3.5 gallons per flush (gpf) or greater (a non-ULFT) to be eligible. The toilet to be replaced must have been installed prior to 1992.
4. You may install the toilet(s) yourself or you may also hire a licensed contractor.
5. Return the original dated receipt and/or plumber's invoice with the price, model and brand of each toilet listed individually, and the completed application. Keep a copy for your records.
6. Submitting a signed application represents agreement to have the City of Sacramento verify installation of the toilet, with your accompaniment. City of Sacramento will schedule an inspection.
7. Rebates are up to **\$125 for ULFT**, up to **\$175 for a HET** and up to **\$200 for a Commercial HET**. Call the City of Sacramento to verify the amount you are eligible for. Total rebate amount will not exceed money spent. Eligible expenses include tank, bowl, seat and tax.
8. The City of Sacramento will issue rebate checks within 90 days of receipt of your completed application materials.
9. The City of Sacramento is required to send IRS form 1099 to the customer and the IRS when rebates total \$600 or more.

## Qualifications

1. Purchase of material must occur within the program period of **January 1, 2010 to June 30, 2010**. The number of rebates is dependent upon the availability of program funds. Call the City of Sacramento to see if funds are available.
2. The location of installation must be served by the City of Sacramento.
3. Residential, commercial, industrial, institutional and multi-family applicants are eligible.
4. Replacement of one ULFT with another ULFT is not eligible for rebate under this program.
5. New construction is not eligible for rebate under this program.

## Permitting

Building permits are not required when a residential customer simply removes and installs a toilet on existing plumbing. A permit is required when a plumbing fixture will be relocated or you are a business customer.
