Establishments primarily engaged in selling used general merchandise are classified in Industry Group 593, and those selling general merchandise by mail, vending machine, or direct selling are classified in Industry Group 596.

## **57 - HOME FURNITURE, FURNISHINGS AND EQUIPMENT STORES**

This major group includes retail stores selling goods used for furnishing the home, such as furniture, floor coverings, draperies, glass and chinaware, domestic stoves, refrigerators, and other household electrical and gas appliances. Establishments selling electrical and gas appliances are included in this group only if the major part of their sales consists of articles for home use. These stores also repair household appliances, radios, televisions, and stereo equipment, but establishments primarily engaged in repair of these products are classified in Division I, Services. Dealers primarily engaged in selling antique and secondhand furniture are classified in Industry Group 593. Stores furnishing interior decorator service are classified according to the merchandise handled.

This major group includes retail establishments selling prepared foods and drinks for consumption on the premises; and also lunch counters and refreshment stands selling prepared foods and drinks for immediate consumption. Restaurants, lunch counters, and drinking places operated as a subordinate service facility by other establishments are not included in this industry, unless they are operated as leased departments by outside operators. Thus, restaurants and lunch counters operated by hotels are classified in Services, Major Group 70; those operated by department stores in Major Group 53. Bars and restaurants owned and operated for members of civic, social, and fraternal association only, are classified in Industry 8641. Mobile food and dairy wagons are classified in Industry 5963.
