#### Parks and Recreation Commission

The Parks and Recreation Commission serves as a bridge between the community and the Department on issues related to parks and recreation. The Commission works with staff to review and develop policies to improve and enhance facilities and programs throughout the City. The Commission is comprised of 11 members who each represent one of the City’s 11 Planning Areas. Members serve four year terms and are appointed by the Sacramento City Council.
