**8. Letter of Intent: Use of the Northern Portion of the Sanitation District Bufferlands for a Regional Park**

**Location:** Between the North Beach Lake Levee and the proposed extension of Cosumnes River Boulevard, Interstate 5 and Franklin Boulevard (Delta Shores Project Area), Planning Area 11, Council District 7

**Recommendation:** Recommend the City Council authorize a letter of intent between the Sacramento Regional County Sanitation District and the City of Sacramento regarding use of the northern portion of the Sacramento Regional Water Treatment Plant bufferlands for a regional park

Mary de Beauvieres, Principal Planner, displayed maps of the project area including proximities to surrounding development and public spaces, and reviewed the item including public access, passive park uses, funding and timing. Commissioners and staff discussed roles and responsibilities between the City and the Sanitation District; concerns about sensitive environmental areas, proximity to Stone Lakes National Wildlife Refuge, and any impact on wildlife; future public uses; planned trails within and connecting to the site; the potential heavy impact on surrounding neighborhood and community parks given this park would remain largely undeveloped; considerations with the lack of developed active recreation facilities; concerns this may be viewed as a

precedent that future regional parks would not provide for the broader recreation needs of citizens, and confirming that while utilizing this bufferland as a regional park reflects limitations and financing challenges, the opportunity it presents and use as a preserved natural area with public access is positive.

**Action:** Moved, seconded and carried to support a letter of intent and advise that future regional park facilities have more diversified recreation opportunities.
