Minor Permits \$75

Permits requiring only one inspection as determined by the City – includes residential electric service, water service, sewer service, gas service, water heater replacement, and sewer disconnect.

Inspections Based on Project Valuation

- A. Building Permit Fees shall be based on the project valuation determined by the Building Official (Section 9.49 City Code).
