**7. Amendment to City Code to Increase Penalty to Harm or Abandon Wildlife in City Parks**

**Recommendation:** Support proposed amendment to the City Code increasing the penalty to a misdemeanor to kill, chase, wound or capture any wild or domestic bird or animal in a city park; or to abandon any animal in a city park

Alan Tomiyama, Recreation Manager, introduced the item. Mr. Craig Powell, Park Committee Chair with the Land Park Community Association, and Ms. Lisa Nava, District Director for Councilmember Robert Fong, also spoke to the item. The need for the recommendation arose through acts of poaching within William Land Park. Commissioners, staff and guests discussed the overall issue, public education efforts, cultural awareness concerns, enforcement efforts, and the recommended increases to penalties. Separately, increasing penalties for abandoning animals in City parks was discussed, whether or not the proposed penalty was too severe, and whether or not to separate the two issues and focus more attention on poaching issues.
