6. Sacramento County Regional Parks and Open Space Funding Initiative from the Grassroots Working Group

Mr. Bill Davis, Volunteer Chair of the "Grassroots Working Group", reviewed the item as outlined in the agenda packet. Commissioners asked questions about methods of financing, proposed service levels and types of services, how a "regional park" would be defined for voters, how City residents would benefit from a funding initiative focused on Sacramento County parks and the American River Parkway, and public outreach. Commissioners advised to emphasize benefits to all voters including connectivity of the system through trails and waterways. Commissioners asked the Working Group to consider including unfunded development needs in North Natomas and Sutter's Landing Regional Parks as part of the overall initiative, and how the City and County might work together on current funding initiatives.

Commissioners and staff reviewed a list of potential agenda items for calendar year 2011. Commissioners requested the following topics be discussed in 2011, and perhaps included in an annual report as recommended by the Chair: status of the Department's safety improvement plan, swimming pools and concerns about closure due to budget cuts, current deficiencies in parks, statistics of public use, and park reservation use and related fee revenue.

Chair Rewers and Vice Chair Cooke will seek assistance from commissioners and work with staff to produce an annual report to be reviewed with the Commission in February, and then presented to the City Council.
