Projects exceeding \$15 million in valuation, Housing cases, Master Plans, and OSHPD projects require approval from the Plan Review Manager. Expedite requests for these project types may take up to two business days to process. Approval of these project types is valid for five (5) working days beyond the date signed. If the approval expired, resubmit the form for approval.
