## **Application for New Building Electrification Infeasibility Waiver**

The City of Sacramento adopted local amendments to the California Building Standards Code (<a href="Chapter 15.38">Chapter 15.38</a> of the Sacramento City Code) requiring all newly constructed 1-3 story buildings to be all-electric, with limited exemptions. Sacramento City Code provides for an infeasibility waiver process for projects where all-electric is shown to be infeasible by the applicant. **ALL-ELECTRIC** means a building that does not have fuel gas piping installed on the lot or within the building; and uses electricity as the sole source of energy, except for emergency power systems that are required to serve essential facilities or are otherwise required by law or regulation.

The infeasibility waiver determination must be signed by the Building Official and included with the waiver application material (recommendation, supporting documentation, and consultant's report) before formal submittal to the Building Division for building plan check. Effective January 1, 2023, building permit applications for newly constructed 1-3 story mixed fuel buildings **WILL NOT** be accepted, unless the project is eligible for a limited exemption or has an approved infeasibility waiver.

APPLICATION FEES AND CONSULTANT FEES FOR THE INFEASIBILITY WAIVER MUST BE PAID TO THE CITY OF SACRAMENTO AND RECEIPT ACKNOWLEDGED AT THE TIME OF APPLICATION SUBMITTAL, AND PRIOR TO REVIEW AND DETERMINATION OF THE WAIVER REQUEST.

APPLICATION FEE (\$492), CONSULTANT SERVICES FEE (\$1,500), AND APPEAL FEE (\$1,640) ARE NON-REFUNDABLE.
