SUBJECT: **NOTICE OF INTENT TO ADOPT THE MITIGATED NEGATIVE DECLARATION**

PROJECT: Sump 85 Reconstruction Project (X14130904)

COMMENT

PERIOD: March 4, 2021 to April 2, 2021

LOCATION: The existing Sump 85 pump station is located at 2537 Edgewater Road in the City of Sacramento. The new pump station would be constructed on a 1-acre site bordered by Edgewater Road (west), vacant land (north and east), and Bay Drive Drainage Ditch (south) in the City of Sacramento, Sacramento County (APN 263-0110-026).

The City of Sacramento, Department of Utilities has completed preparation of an Initial Study/Draft Mitigated Negative Declaration (IS/MND) for the Sump 85 Reconstruction Project (X14130904) and intends to present the document for adoption as part of project review. The IS/MND has been prepared in accordance with the California Environmental Quality Act (CEQA) and Environmental Review Process Guidelines for State Revolving Fund Loan Applicants (SWRCB 2015, as updated in 2017) and is expanded beyond the typical content requirements of an initial study to include additional "CEQA-Plus" information.

The document is now available for a 30-day public review and comment period. The comment period is from **March 4, 2021 to April 2, 2021**.

PROJECT DESCRIPTION: The project would replace the aging Sump 85 sewage pumping station with a new pump station that would be located 0.06 mile north of the existing Sump 85 site. The new pump station would include new submersible pumps, wet wells, manholes, below- and above-grade piping, vertical surge tanks, a generator and electrical equipment building, fiber optic line, a microwave communications tower, and a restroom. The project would also include demolition of the existing pump station and associated tie-in work related to commissioning of the new station and decommissioning of the existing station.

Written comments regarding the Draft Mitigated Negative Declaration should be received by the Community Development Department, **NO LATER THAN 5:00 p.m. on April 2, 2021** (NOTE: due to COVID 19, the Public Counter is CLOSED). All comments should be submitted via email or mailed to:
