Types of Funding Sources and Resources Available

 Grant and loan programs Application process (short) 	 Grant or loan programs (e.g. brownfields) Application process (long) 	 For-profit lending Limited funds available, often restricted due to high financial risk 	 One-Time Donations (e.g. Grocery store donations, corporate sponsorships)
 City Council Grant and loan programs Application process (short) 	 Significant requirements to meet funding eligibility and comply with regulations 	 Significant requirements to meet funding eligibility and comply with regulations Can also act as donors/ sponsors 	 Recurring or Annual Giving (e.g. Community Membership) Philanthropic Support Donated Services (e.g. graphic design)


