

State Homeless Hiring Tax Credit

Overview

- Assembly Bill 150
- Taxable Years from January 1, 2022 through December 31, 2026
- Employers receive \$2,500 to \$10,000 per employee, based on hours worked
- Limit of \$30,000 of credit per employer each taxable year
- State offering \$30 Million of credit annually
- Employers will claim the credit when they file their tax return, unused credit can be carried over 3 yrs

- ▶ Employer must make a tentative tax credit reservation (starting January 3/4, 2022) within 30 days of completing the [New Hire reporting requirement](#) with the Employment Development Department
- ▶ Employers will need to obtain a Homeless Hire Tax Credit Certificate from a certifying organization
- ▶ Employers must pay wages equal to or greater than 120% of their California minimum wage

Employer Eligibility

Annual Tax Credit Amounts per Employee

Hours worked	Credit amount
0 – 499	\$0
500 – 999	\$2,500
1000 – 1499	\$5,000
1500 – 1999	\$7,500
2000 or more	\$10,000

Employee Eligibility

- ▶ Be able to provide the required information for employment, including Social Security Number;
- ▶ Be currently/recently homeless (within 180 days of hire) or be receiving services from a homeless services provider; and
- ▶ Be certified by a certifying organization. The certifying certificate expires 1 year after issuance.

Certifying Organizations

- ▶ Include continuum of care programs and community-based service providers
- ▶ The HHTC Certificate is to be completed by:
 - ▶ A Continuum of Care, OR
 - ▶ A Community-based Service Provider

Certifying that the eligible individual to be employed is experiencing homelessness currently or within the last 180 days or is receiving services from a homeless services organization

Include CoC Name and Number:

Sacramento City and County CoC - CA-503

Certifying Organizations

Certifying organizations will:

- Provide their email address to obtain the HHTC Certificate

- Complete the certificate, print, and sign it
- Provide the completed certificate (or scanned copy) to the:
 - Employer; OR
 - Employee (to give to the employer)

(Employers keep the certificate on hand in case they are audited by the State Franchise Tax Board)
