

## **Second Saturday Art Walk**

### *Things to Consider to Make it Safe and Successful*

The Second Saturday Art Walk occurs the Second Saturday of each month. **The City of Sacramento permits the use of public property for vending and outdoor amplified sound between the months of April and October, from 4:00 PM to 9:00 PM.** The boundaries of Second Saturday are 16<sup>th</sup> Street to 24<sup>th</sup> Street, and I Street to Capitol Mall.

Participants wanting to display and/or sell art outside must obtain an Art Vendor permit. Private Property owners who have multiple vendors must obtain a Multi Use Vendor permit. Activities, which include outdoor amplified sound, are required to have an Amplified Sound permit.

#### **FIRE PERMITS**

A permit is required by the Sacramento Fire Department for all open flame devices and/or performances with fire. Please contact the Sacramento Fire Department's Special Event Unit at **(916) 808-6496** to obtain a Fire permit.

#### **ALCOHOL PERMITS**

If you are planning to sell or serve alcohol at your event, you will need to obtain a One-Day Alcohol Beverage Permit from the Sacramento Police Department and a Special Daily License from the California Department of Alcoholic Beverage Control (ABC). This license authorizes the temporary sale or serving of alcohol for consumption on the premises. Sale or consumption off the premises is strictly prohibited. To qualify for a Special Daily License you must be an existing non-profit organization.

To begin the permit process, contact the Sacramento Police Department for a One-Day Alcohol Beverage Permit Request.

Once you obtain your One-Day Alcohol Beverage Permit from the Sacramento Police Department, contact ABC at, **(916) 227-2002**, to obtain a Special Daily License.

#### **OUTDOOR AMPLIFIED SOUND PERMITS**

Bands and vendors that engage in activities which include outdoor amplified sound are required to have an Amplified Sound permit. All applicants must have the signature of the property owner, or lessee where music is proposed. If using public property the signature of the nearest property owner/lessee is required.

#### **OUTDOOR VENDOR PERMITS**

The artwork displayed and sold during Second Saturday may not be mass-produced, manufactured or imported. All artwork must be original, handcrafted and artistic merchandise produced by the vendor. All applicants must have the signature of the property owner where there art will be displayed/sold. If using public property the signature of the nearest property owner is required. Private Property owners who allow displays by multiple vendors on their property must obtain a Multi Use Vendor permit, assuming responsibility for compliance by its vendors.
