### Incident Summary

This Use of Force occurred at the termination point of the vehicle pursuit written on the same report number. As the suspect pulled into her driveway on her motorcycle, Ofc. Osmond, the passenger in the primary pursuing Police vehicle, exited his door and ran towards the suspect. To prevent her from escaping, Ofc. Osmond used his body momentum to push the suspect off the motorcycle and down onto the ground. The suspect's helmeted head struck the side of her trailer, giving her a bloody nose, and apparently her right wrist suffered a fracture from the take-down when her and the motorcycle fell over. That was the only force used other than control holds to get her handcuffed and into custody.

The suspect, (S) [REDACTED] was arrested for 2 felonies (2800.4 VC, 2800.2 VC) and 6 misdemeanors (148 PC, 23152(G) VC, 23247(E) VC, 11350 HS, 11364 HS, 14601.2 VC) and had priors for 245 PC and a multitude of drug/alcohol related arrests in her past.

Also to note, I discussed with Ofc. Osmond various other post-pursuit tactics to take someone into custody, such as standard felony vehicle stop tactics and ACB control holds and tactics specific to suspects on motorcycles/bicycles. Ofc. Osmond was very receptive to the information discussed.

After reviewing the associated ICC and Body Worn Camera Footage as well as the corresponding report, and as the Use of Force occurred at the end of a dangerous pursuit, and used to prevent the escape of (S) [REDACTED] my determination is that this Use of Force was both Justified and within our Use of Force Policy.

On 04/05/19 at approx. 1727 hours, Ofc. Fisher #1004 and I (Ofc. Osmond #982) (2C65) were working uniformed patrol in the area of 49th St. and Broadway. We were driving a fully marked SPD patrol vehicle and both wearing full SPD Officer's uniforms. Our in car camera and body worn cameras were all activated during the following incident.

We attempted to conduct a vehicle enforcement stop on a motorcycle with a solo driver. The driver was later identified as [REDACTED] via WebKPF booking photo. [REDACTED] fled from us and a vehicle pursuit was conducted. See Officer Fisher's observations for details regarding the enforcement stop and pursuit.

During the pursuit we remained in the number 1 position the entire time, Ofc. Fisher was driving and I was in the passenger seat notifying additional responding Officers via radio. Except for brief moments while on highway 50, I did not lose sight of suspect [REDACTED] through the pursuit.

At the termination of the pursuit, suspect [REDACTED] pulled into the driveway of [REDACTED] Dutchess Way (later determined to be her residence). Suspect [REDACTED] stopped the motor cycle and started to put the kick stand down. In order to prevent her from fleeing on foot or into a nearby residence, I gave chase on foot. I exited our patrol vehicle and ran at suspect [REDACTED] who was still seated on the motorcycle. As I reached suspect [REDACTED], I wrapped my arms around her upper body, and used the momentum and weight of my body to take her to the ground. Suspect [REDACTED] fell to the ground and hit her face on the side of her residence. Suspect [REDACTED]'s motorcycle fell with us, slightly on top of suspect [REDACTED] and beneath me. I took ahold of suspect [REDACTED]'s right arm and ordered her to present her left arm which was underneath her body. Additional Officers arrived and assisted in detaining her in handcuffs without further incident.

Ofc. Moua and I conducted a search incident to arrest of suspect [REDACTED]'s person. I did not locate anything of evidentiary value.

Suspect [REDACTED] was then detained in the back seat of our patrol vehicle. I later attempted to read suspect [REDACTED] her Miranda rights, suspect [REDACTED] would not let me finish reading her rights and then she advised that she wanted an attorney.

I observed a small abrasion on the right cheek of suspect [REDACTED]'s face. The abrasion was approx .75 inches in diameter, had bruising and was slightly bleeding. It was apparent that suspect [REDACTED] obtained the injury at the termination of the pursuit. Suspect [REDACTED] did not appear to have any other injuries at that time, nor did she advise of any further injuries.

Fire Engine 62 of the Sacramento Metro Fire Department arrived on scene and treated suspect [REDACTED]. Fire personal advised that suspect [REDACTED] did not need immediate medical attention and did not need to go to the hospital at this moment. Fire personnel cleared the scene.

[REDACTED] was placed under arrest and transported to jail. While at jail, [REDACTED] removed her jacket and I observed her right wrist was swollen and slightly out of line. Suspect [REDACTED] complained of pain to her right wrist, left shoulder, right ankle, face and left rib. We then transported suspect [REDACTED] to Sutter General hospital where she was treated for her injuries.

While at the hospital, [REDACTED] spontaneously stated that the reason she did not stop was because she did not want her motor cycle to be towed. It should be noted that I deactivated my body worn camera while inside the hospital for privacy reasons.

I filled out a property booking receipt and placed a copy of the receipt into [REDACTED]'s jail property bag. Her items were later booked for safe keeping at SPD Property.

I observed a black Harley Davidson motorcycle (CA Lic: ██████████) traveling eastbound on Broadway at the intersection of 49th St. The motorcycle was in the left hand (northbound) turn lane at the intersection of 49th St and Broadway. The motorcycle proceeded straight (eastbound) from the left turn lane, in violation of 21641(a) VC. I accelerated to catch up to the motorcycle. I observed the motorcycle had a registration tag noted it had been registered last in 2018, in violation of 4000(a) VC. Ofc Osmond and my department issued body worn cameras and in car camera were activated throughout in the incident.

87 MPH (in violation of 22350 VC). The motorcyclist made a northbound turn on 65th St from Broadway against a red circular light (in violation of 21453(a) VC).

at the circular red light at the intersection of the US-50 eastbound off ramp and Bradshaw Rd. The motorcyclist proceeded to make a right (southbound) turn onto Bradshaw Rd without coming to a complete stop (in violation of 21453(a) VC).

motorcycle was later towed by Capitol City towing.

See Ofc Osmond's observations for details regarding [REDACTED]'s injuries.

I retrieved the glass pipe I observed fall out of [REDACTED]'s pocket. I noticed the glass pipe had a burnt, powdery substance on one end. I looked down the other end of the pipe and observed what appeared to be metal shavings within the pipe. Based on my training and experience, I knew this type of pipe to be a pipe commonly used for smoking cocaine or cocaine base. I used a Nartec cocaine test on the burnt, powdery substance and another Nartec cocaine test on the inside stem of the pipe, both of which resulted with a presumptive positive for cocaine. This pipe was seized and later booked as evidence at 555 Sequoia Pacific.

[REDACTED] spoke rapidly and had flight of thought. She struggled to focus and chain together coherent thoughts.

I observed [REDACTED] had blood shot and watery eyes (objective signs of intoxication). [REDACTED] was wearing goggles while on her motorcycle, so I do not believe her blood shot and watery eyes were due to wind exposure. At one point, [REDACTED] spontaneously stated, "I drank some alcohol." Based on [REDACTED]'s objective signs of intoxication, spontaneous statement, and narcotic paraphernalia possession, I believed [REDACTED] was under the influence of alcohol and illegal narcotics. SFST's were not attempted due to [REDACTED]'s erratic behavior and lack of cooperation.

Sgt Mantell #3109 responded to the scene. Sgt Mantell photographed the scene at [REDACTED] Dutchess Way and [REDACTED]'s motorcycle. Sgt Mantell took 15 total photographs which he later submitted as evidence at 300 Richards Blvd.

Additional Officers conducted a canvas of the area around the termination (see supplemental observations for further information).

Ofc Osmond and I transported [REDACTED] to Sacramento County Main Jail (SCMJ) to be booked on the following charges: 2800.2 VC, 2800.4 VC, 11364 HS, 23247(e) VC, 21461 VC, 23152(g) VC, and her outstanding warrant.
