- B. Temporary permits are limited to three (3) permits per household. If more permits are needed, please call 916-264-5011 or email ParkingCSR@cityofsacramento.org to place your special request. **Please note that simply placing a request does not guarantee a permit**.
- C. Parking Services reserves the right to limit the extension period of permits.
- D. Current residents: Online 24-hour Temporary Permits are available at www.sacpark.org. Requires account registration and possession of a valid Vehicle or Visitor Permit.
