

Non-Exclusive Commercial Solid Waste Collection Franchise Application

Pursuant to Sacramento City Code, Chapter 13.24

To haul waste material in the City of Sacramento, you must hold a Non-Exclusive Commercial Solid Waste Collection Franchise. This is the Application to start the Non-Exclusive Commercial Solid Waste Collection Franchise process.

The review for a City of Sacramento Franchise Application will be as follows:

- 1) Applicant sends completed application and all attachments to: wastecompliance@cityofsacramento.org
 - a. Applicants will receive an email confirmation within 3 business days advising the application has been received and is being reviewed.
- 2) Within 60 days of submittal, applicants will be notified of either: 1) recommendation to City Council to award a franchise; 2) incomplete application; or 3) denial.
 - a. A completed application with recommendation to City Council to award a franchise does not confer a franchise.
 - i. A Non-Exclusive Commercial Solid Waste Collection Franchise is effective when the applicant and the City have fully executed and signed a written agreement, and the applicant satisfies all the requirements and conditions set forth in Chapter 13.24 of the Sacramento City Code and the franchise agreement.
 - b. If the application is incomplete, the City of Sacramento will provide email notice to the applicant that the application is incomplete, identifying what information or materials the application is missing.
 - c. If the application is denied, the applicant will be notified in writing of the reason(s) why.

D. Franchisee Fleet Inspections

The following shall apply to Franchisee fleet:

- All Franchisee vehicles shall be inspected by Sacramento County Environmental Management Department (EMD) before they may be used for commercial solid waste operations.
 - Sacramento County EMD will contact Franchisee to schedule an appointment for vehicle inspections. A per vehicle inspection cost will be charged.
- A vehicle franchise decal for each vehicle that has passed an inspection will be mailed to applicant and
 must be affixed to the vehicle. It is illegal for any vehicle not clearly displaying this decal to collect
 commercial solid waste in the City of Sacramento.

Note: Any change in the vehicle inventory during the term of the Franchise Agreement, such as adding a new truck, must be reported on a revised Commercial Solid Waste Vehicle Inventory form. Email the revised form to wastecompliance@cityofsacramento.org. New vehicles must be inspected by Sacramento County EMD before being put into service.

SECTION 8 – FINANCIAL REVIEW (New Applicants Only)

New applicants must provide satisfactory proof to the Solid Waste Manager that the applicant has adequate financial resources to conduct commercial solid waste collection services.

Examples of satisfactory proof include: an Audited Financial Statement; an Irrevocable Letter of Credit; a Bond in the amount of \$10,000 or refundable cash deposit to the City of \$500 for each of the vehicles identified in section 3.B.

New applicants must attach proof of adequate financial resources as attachment to this application for review.

SECTION 9 – CERTIFICATION

Read the following statement carefully:

Franchises are issued by the City of Sacramento. All collection services shall be provided by the Franchisee. Sub-contracting and other forms of transferring obligations and/or responsibilities imposed by the Franchise are prohibited except as expressly allowed by Chapter 13.24 of the Sacramento City Code.

I understand that I must have a valid City of Sacramento Franchise Agreement to collect and/or haul commercial solid waste in the City of Sacramento.

I hereby grant the City of Sacramento and the Sacramento County Environmental Management Department the right to inspect any and all equipment and/or facilities and/or records during reasonable hours to ensure compliance with Chapter 13.24 of the Sacramento City Code. I understand that denial of such entry or the violation of Chapter 13.24 shall be grounds for suspension or termination of said Franchise.

I hereby certify that the information in this application package is true and correct, that the operation will be conducted in accordance with the information contained and certified herein, and in accordance with the requirements of the City of Sacramento, Recycling and Solid Waste Division. Further, I hereby certify that I have access to suitable facilities for keeping vehicles and equipment clean and in good repair and that I own or will have access to reasonable local office and billing facilities.

I hereby certify that any financial books and accounts for all revenue and income arising from the Franchise operations listed in this application are kept in a manner that conforms to Generally Accepted Accounting Principles.

I hereby certify that I or the company(ies) listed in this application will show proof of insurance pursuant to Section 5 of this application package prior to commencing business related to this Franchise.

I hereby certify that I owe no outstanding fees of any kind to the City of Sacramento nor are there any federal or state tax liens filed against me or any property I own.

I hereby state that all information contained in the franchise application shall be kept up-to-date by the applicant who shall file a new verified statement within forty-eight (48) hours of any change indicating in detail the nature of any change in the information.
